In this context, I beg your permission to record my immense gratitude to your great persona for the delivery of the landmark judgement dated 01.04.2004 (International Fools day) in RP No.708/2003 in or O.P. No.9552/2002 categorically declaring the rule of the defacto ministry of the then of Kerala led by then Chief Minister of Sri. A.K. Antony 'without love to all manner of people', on a forged oath / affirmation in Malayalam language, was against the noble concept of democracy and hence unconstitutional. This was done by thee in

thy earlier avatar as justice of the Hon'ble High Court of Kerala. Subsequently, compulsively the state of Kerala adopted the Constitutional oath / affirmation which led to the momentous event of ushering in of Constitutional democracy in the state of Kerala, a territorial area which is in the list of states as per schedule I of Indian Constitution. As the master architect of this epoch making event thy name will be perpetually enshrined in the annals of the Constitutional history of India as a legendary figure of justice who hailed the passion of Christ-'love'- in the landmark judgement rejecting the Pontius Pilate's indiscretion of 'without love' resulting the crucifixion of an innocent and noble son of God. History will confer on the an enviable sobriquet of the 'father of the Constitutional democracy of Kerala'. The people of Kerala who believe in representative democracy and rule of law are also obliged to your Eminence as you have not covertly or overtly or indicated that the usurpation of political power, by the ministers of Kerala led by former Chief Minister Sri. A.K. Antony in the month of May 2001 adopting a forged oath / affirmation of oath of office and continuation in power till 31.08.2004 despite the interference of the Hon. High Court challenging its authority, is not an act of high treason or that these pseudo ministers had not seceded State of Kerala from the Constitutional scheme of India.

In this context, I, with solemn respect to the Constitutional values and greatness of our civilization, beseech you with utmost humility and sobriety to direct the Chief Secretaries of all States and Union Territories not to execute any convicts of India in death now till the disposal of the representation dated 10.12.2011. on human rights day, submitted to Her Excellency the President of India by t his petitioner, in a humane and lawful manner.

I earnestly hope and desire for an opportunity to me for being heard by your authority of grace and power on my humble supplication for the life of my fellow citizens and the human passion of love.
