SUB :- Insult of National Honour-Taking treasonable oath while assuming office of C.M. of Kerala by Sri. A.K. Antony - Aggravation of Insult by inducting him as Defence Minister of India-reg.

Ref:- Our letter No SAVE.10/04 dated.17.07.04 addressed to your Excellency.

Respected Sir,

Secretariat Aikya Vedi (SAVE) is an association of Secretariat employees of Kerala having abiding faith in the sovereignty of India and its unity and also the rich and varied heritage securely buttressed by the democratic structure envisaged by our Constitution. We profoundly feel happy that after a sustained campaign from 02.02.02 our association has succeeded in altering the treasonable, antinational and antipeople oath of office of the ministers of Kerala, while Sri. Oommen Chandy took the oath of office as Chief Minister in the month of August 2004 after the resignation of Sri. A.K. Antony due to some mysterious reasons. But we are concerned that the rule of law was not allowed to take its own course by the nation headed by your Excellency as no penal action was taken against the popular leaders under the leadership of Sri. A.K. Antony, who insulted the Constitution of India, a living symbol of our sovereignty and national Honour, by taking a treasonable oath while assuming office that they will do justice to

people "Without love", departing from the oath prescribed in the Third Schedule to our Constitution. Through this treasonable oath these popular leaders headed by Sri. A.K. Antony declared publicly in an antinational manner that our Constitution is a document without love, is satanic in nature. By this act on that day they gangraped and murdered the Constitution of one billion people of India. If this sort of disgrace was meted out to any religious sacred texts like Holy Bible or Holy Koran etc. the whole world would have been in fury and its flames would have wreaked havoc in the whole society. But we have learnt with deep pain and shock that the prime accused in the insult to our Constitution Sri. A.K. Antony has been inducted in the cabinet of Sri. Manmohan Singh as Defence Minister, thereby implicitly declared by responsible constitutional authorities that the text of Constitution, the national honour and rule of Law are dispensable and irrelevant in the present day India.

It is the most painful and disturbing fact of the entire democratic world, not only India, that on the 17th May 2001, the Ministry headed by Sri.A.K.Antony, now Defense Minister of India assumed Office by taking an oath drafted in Malayalam by some antinational aides of Sri. A.K.Antony cruelly and mercilessly binding them to do justice to all manner of people "Sneham Koodathe" ("without love") instead of "Pakhshapatham Koodathe" ("without favour"). They "without love" subverted and negated the divine equation that "God is love". Without love these Khadi clad leaders negated the Gandhian equation "Love is God and Truth". We hope that as a person having living experience with Malayalam Language and "sneham" (love) will not have even an iota of doubt or hesitation in declaring that the crime committed by Sri. A.K.Antony by his unconstitutional Oath of Office is an insult to our Constitution and a grave assault on republicanism amounting to treason of the highest degree. This swearing in ceremony on 17th May 2001 was a "Spectacle of rarest of rare cases" as observed by the Hon: Supreme Court in the Parliament attack case of 13th December 2001 in which Mohammed Afsal was awarded death sentence. Though the former case was attack on the philosophy of democracy, the latter was an attack on the iconic structure of our democracy i.e. the parliament. But the prime accused in the former case Sri. A.K. Antony, who took a treasonable Oath while assuming office has been rewarded by the induction to the Manmohan Singh Cabinet. Head of any Nation of the world, who shall be the fountain head of mercy of the nation, cannot sit in judgement on any mercy petition from a person awarded capital punishment by a court of law, if that head of nation exonerates a minister of his nation who ruled the people taking an Oath to rule without love'

because mercy is a beautiful flower in the Tree of love in our heart. It is very obvious that the decision of allowing or disallowing this mercy petition will be per se a mockery of justice ridiculing the Raja Dharma of this ancient nation of the world.

The above insult of our Constitution assumed a diabolic form as Sri. Antony had not relinquished office or took the Constitutional Oath and got subscribed to the Constitution despite the fact that the insulting mistake in his Oath (Continuation in office by him proves that the Oath was taken with the full application of mind and it was so admitted before the Hon: High Court of Kerala) was brought to the public notice by our association and also by the Malayalam visual media within a couple of months after his assumption of office. He did not yield to the Constitution after a notice was served on him by the High Court of Kerala in an OP filed by our association to declare the two Govt. Orders against the State Govt. Employees cruelly taking away their legitimate rights unconstitutional and having no force of law as having been issued by a cabinet which has been taken the traitorous oath to rule the people 'without love'. In this OP Sri. A.K. Antony averted the legal scrutiny of the seditious nature of his Oath of office by means of a big lie before the Honour of High Court of Kerala that this impugned orders were withdrawn. As a petition filed under section 15(1) of the Contempt of Courts Act 1971 for initiating criminal contempt against Sri. A.K. Antony was rejected by the Advocate General of Kerala, an appeal was filed by our association before the Honourable Supreme Court of India to examine whether Sri. A. K. Antony had taken a treasonable Oath of office while assuming the office of the Chief Minister of Kerala which disables his cabinet to approve and issue orders taking away the legitimate rights of the Govt. employees of the state of Kerala (CA No. 7000/2006) and notice has been issued to Sri. A.K. Antony on this matter.

It is strange and unfortunate that a person who has no qualms in ruling his home state of Kerala without love as per his Oath of office as Chief Minister has been entrusted by your Excellency the task of dealing the Defence portfolio of the Union Government of India. The Former Union Minister of India Sri. Natwar Singh was removed from office on the simple ground of having betrayed the trust of Smt. Sonia Gandhi, the convenor of U.P.A. In the case of the present Defence Minister A.K. Antony, he had betrayed the trust of crores of the people of Kerala by his seditious Oath of office.

It is an accepted fact that rule of law is the basic structure of our Constitutional democracy ensuring sovereignty of the people. But in the present India headed by your Excellency the enforcement of rule of law is in a discriminatory manner. A few month back a cine actress and prominent social worker Smt. Jaya Bachchan was removed from Rajya Sabha on the charge of

...ing office of ... who ... committed the same violation of Constitutional provision, were allowed to sit in the Parliament. The Rajasthan Govt. is praying before the Hon. High Court of Rajasthan to enhance the jail term for the film celebrity Sri Salman Khan in the 1998 Black Buck poaching case for having treated animals "without love". While Sri A.K. Antony who ruled the state of Kerala taking an Oath to rule "without rule" human beings has been appointed inadvertently as the Defence Minister of India.

In this context our association respectfully request your Excellency to invoke your Majestic conscience and decide on the following aspects in consultation with the Hon. Chief Justice of India and intervene in an appropriate manner assuming the solemn duty bestowed on your Excellency as the Defender of the Constitution of India.

(a) Whether the Oath of office taken by Sri. A.K. Antony while assuming office on 17th May 2001, as the Chief Minister of Kerala is treasonable.

(b) If it is found so, is he eligible to occupy the office of the Defence Minister of India.

The ministers were administered the forged oath of office to rule the people of Kerala 'without love' (Sneham koodathe) instead of 'without favour' (Pakshapatham koodathe).

By ruling the people of Kerala 'without love' on oath or affirmation by these ministers, the State of Kerala was seceded from the Constitutional scheme of India. This cruel action also did amount to high treason as it was a war against the people and Govt of India. But the nation had not taken cognizance of any crime against them as they are treacherous politicians of might and influence enjoying enormous impunity.

The only consequence met by the above ministers who deceitfully usurped political power was that the High Court of Kerala has admitted a petition challenging the monetary benefits enjoyed by them for committing this mortal sin against the nation (W.P(C) No. 32509/2009)
